

The Eagle Crest Resort (ECMA) water system draws its drinking water from two active wells. Source water assessments have been compiled by the Oregon Department of Environmental Quality and the Oregon Health Authority. These assessments contain detailed information about the water system, including potential pathways of contamination. The source water assessments are available upon request. The assessments conclude, and the water quality results described in this report substantiate, that there is minimal susceptibility to contamination.



In order to ensure that tap water is safe to drink, the U.S. Environmental Protection Agency (USEPA) and Oregon Health Authority prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. U.S. Food and Drug Administration regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Your drinking water is routinely monitored for these contaminants according to federal and state laws. This year's water quality table shows the results of drinking water tests for the period of January 1st to December 31st, 2024. Some contaminants are tested less than once per year; therefore, the most recent results are displayed in the table. As you can see from our most recent test results, ECMA drinking water meets all state and federal standards.

The sources of drinking water, both tap and bottled water, include rivers, lakes, streams, ponds, reservoirs, springs and wells. As water travels over the land or underground, it can pick up substances, or contaminants such as microbes, inorganic and organic chemicals, and radioactive substances.

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock, and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm-water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.

Pesticides and Herbicides comes from agricultural, urban storm-water runoff, and residential uses.

Organic Chemical Contaminants, synthetic and volatile organic chemicals are byproducts of industrial processes and petroleum productions, and also from gas stations, urban storm-water runoff, and septic tanks.

Radioactive Contaminants, naturally occurring or the result of oil and gas production and mining activities.

All drinking water, including bottled drinking water, may be reasonably expected to contain at least some small amounts of some contaminants. It is important to remember that the presence of these contaminants does not necessarily pose a health risk. Water Quality / Consumer Confidence Report



We are pleased to present to you this year's Annual Water Quality / Consumer Confidence Report. This report is designed to inform you about the quality of water and services we deliver to you every day. Our constant goal is to provide you with a safe and dependable supply of drinking water.

ECMA is committed to complying with the Oregon Health Authority requirements to supply you with safe drinking water. ECMA works around the clock to provide top quality water to every tap. We ask that all our customers help us protect our water sources, which are the heart of our community.

Lead is tested at five residential taps every three years in the OWU-ECMA system. The most recent lead testing took place in 2022. Lead was not detected in any of the samples. Another round of lead testing will be conducted in 2025. Lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. ECMA is responsible for providing high quality drinking water and removing lead pipes but cannot control the variety of materials used in plumbing components in your home. You share the responsibility for protecting yourself and your family from the lead in your home plumbing. You

MCLG: Maximum Contaminant Level Goal. The “Goal” is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG’s allow for a margin of safety.

Action Level: The concentration of a contaminant, which, if exceeded, triggers treatment or other requirements that a water system must follow.

can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. Before drinking tap water, flush your pipes for several minutes by running your tap, taking a shower, doing laundry or a load of dishes. You can also use a filter certified by an American National Standards Institute accredited certifier to reduce lead in drinking water. If you are concerned about lead in your water and wish to have your water tested, contact ECMA. As part of our commitment, we completed the initial lead service line material inventory required by the United States Environmental Protection Agency's (U.S. EPA's)

Lead and Copper Rule Revisions (LCRR). The deadline to complete the initial inventories is October 16, 2024.

OWU has completed the inventory of the service lines for our water system and determined it has no lead or galvanized requiring replacement service lines. This determination was made by thoroughly reviewing historical records and performing field investigations. We are proud to report that no lead lines were found. All service lines and house lines have been classified as non-lead in our system. OWU will continue to document service line material information obtained after October 2024 and will update the inventory accordingly. Under the Revised Total Coliform Rule (2016), total coliform occurrence will continue to be investigated as a treatment technique, although it is no longer associated with an MCL. A treatment technique is a required process to reduce the level of a contaminant in drinking water. Emphasis is now placed on the MCL for E. coli because it is a reliable indicator of fecal contamination. One monthly sample is collected in the distribution system and analyzed for total coliform and E. coli.

The most recent lead and copper at-the-tap samples were collected from five residences in 2022. None of the five samples tested for lead and copper exceeded the respective Action Level (AL). Eagle Crest complies with the Lead and Copper Rule. A regulatory Action Level is the concentration of a contaminant which if exceeded triggers treatment or other requirements. The concentration of lead and copper must be less than or equal to the respective AL in at least 90 percent of the samples collected. ND = Not Detected above minimum
